

Child Protection doesn't look like this...

11-year-old who was waiting for placement: how did she end up leaving the building and being raped?

15-year-old reporting a sexual assault from an 18-year-old while they were both staying at the Jane Edna Building.

Jane Edna Building has become a hub for sex trafficking recruitment.

Cleveland police reporting that youth ran away from the building 135 times in the first months of this year.

Average 6-12 children sleeping in the building at a time.

Opportunities for local and state support


ODJFS could temporarily take over; with training, acclimation support

County-Proposed Solutions

Youth Concerns and Questions

Spending \$27,000 on keycards for stairways?

This doesn't safeguard youth.

Issuing an RFP with a "No eject or reject" policy

Risks creating a dumping ground; concerns about placing youth with pending charges with those with specialized needs?

Asking Cleveland Christian Home to hold eight beds for emergency county placements.

Will eight beds be enough? According to reports, there are an average of 6-12 youth spending nights in the Jane Edna building. What services, including therapy, and oversight will be provided? How long will youth stay there?

County-Proposed Solutions

Youth Concerns and Questions

Increasing wages to make Cuyahoga County workers the highest paid in the state.

Money might bring in initial applicants, but will they stay?

What will be done to improve day-to-day working conditions?

Where is the accountability for Cuyahoga County Administration?

It doesn't make sense to take staff members off the child abuse hotline to monitor youth, just because they are the only ones in the building 24/7. Why weren't other staff hired/allocated to fulfill this role?

County-Proposed Solutions

Youth Concerns and Questions

Assigning a sheriff's deputy to the building full-time.

This could be harmful or helpful, depending on how it's rolled out.

What is the deputy's role? Will the deputy be restraining youth? Arresting youth? Keeping them from leaving the building? Will the deputy be trained in trauma-informed care and crisis prevention?

The county is drafting plans to convert the Metzenbaum Center into a residential drop-off site where youth can receive services while awaiting placement.

This is coming full circle to this building's prior role. What measures will be put in place to keep youth from staying there too long?

Will there be trauma-screening, and therapists onsite? What will be done to ensure accountability, child safety, and proper supervision?

County-Proposed Solutions

The county is working with law enforcement agencies to draft a protocol for what steps officers must take before turning over a child to county custody, including de-escalation tactics that might allow a child to remain at home.

Youth Concerns and Questions

Does this risk of undermining the role of law enforcement as mandated reporters?

What if the child feels unsafe in their biological home?

Ohio Revised Code: Section 2151.022. Taking a child into custody.

By a law enforcement officer or duly authorized officer of the court when any of the following conditions are present...

There are reasonable grounds to believe that the child is in immediate danger from the child's surroundings and that the child's removal is necessary to prevent immediate or threatened physical or emotional harm;

There are reasonable grounds to believe that a parent, guardian, custodian, or other household member of the child's household has abused or neglected another child in the household and to believe that the child is in danger of immediate or threatened physical or emotional harm from that person.

Results of 2021 Case Western Study

- Cuyahoga County's rate of confirmed abuse or neglect-related child deaths is significantly higher than the national average.
- Black and Brown children are disproportionately victimized.
- A suspected history of child abuse or neglect is a risk factors for child homicides, and yet early warning signs are too often missed by providers.

Discoveries during 2021 Case Western Study

- Although Cuyahoga is uniquely resource-rich with three major hospital systems that come into contact with child victims of abuse...
- The study revealed that there was limited collaboration between the coordinating agency (DCFS) and hospital systems.
- Typically, a hospital would refer a client to DCFS and allow DCFS to “take it from there.”


